USES

Bostik Super Glu Non-Drip Gel is a single part, fast curing cyanoacrylate adhesive which bonds in seconds without the need for heat or hardener. It provides very strong bonds of high tensile strength, has the advantage of a non-drip consistency, and is extremely economical in use. Bostik Super Glu Non-Drip Gel is very useful in the home and other locations for a variety of assembly and repair applications.

Bostik Super Glu Non-Drip Gel is suitable for bonding porcelain, many rubbers, most common metals, some types of jewellery and most plastics. DIRECTIONS FOR USE

IMPORTANT: Before using Bostik Super Glu Non-Drip Gel refer to the relevant Health & Safety Data Sheet, available at www.bostik.co.uk.

PREPARATION

1. Work on a protected surface as any spillages are very difficult to remove, particularly from sensitive surfaces like fabrics and skin.
2. Make sure that all surfaces to be bonded are clean and dry, being free from dust, dirt and grease.

APPLICATION

3. Unscrew the entire nozzle and remove the plastic collar. Do not squeeze the tube. Replace the nozzle assembly and the safety cap automatically pierces the metal seal.
4. To use, twist off the outer plastic cap and apply a small amount of adhesive to one surface only, drop by drop.
5. Bring the surface together and hold firmly for approximately 30 seconds. (Full strength is achieved after 12 to 24 hours at room temperature. Generally 30 seconds is sufficient for practical purposes).
6. After use, wipe the nozzle with a clean dry cloth (avoiding skin contact).

7. Replace the cap.
8. The bottle is purposely only part full as the air above the adhesive stabilizes it. This air space in the bottle reduces the chance of accidental spillages.

CLEANING

9. Bostik Super Glu Non-Drip Gel has good resistance to most oils and solvents and can be very difficult to remove.
10. Bostik Super Glu Non-Drip Gel bonds to skin very quickly and easily. Should this happen, please do not panic. Do not attempt to pull apart as this may damage the skin. If left the bond will loosen within 30 minutes without doing anything. Hot soapy water and gentle peeling will part the bond; this can take a few minutes.
11. Acetone will very slowly soften set super glue. Before attempting to use, check that it is safe to use a highly flammable solvent and that the surfaces to which the super glue is adhered to are not damaged by the solvent. Do not use acetone or solvents on the skin.
12. Always test before using any solvent.

PRECAUTIONS IN USE

Do not use Bostik Super Glu Non-Drip Gel on polyethylene, polypropylene. Unsuitable for use on absorbent surfaces such as fabric, card and paper. Do not use acetone or solvents on the skin. Do not use for repairing containers that hold hot liquid food or drinks. Unsuitable for bonding windscreen rear-view mirrors. Unsuitable for bonding large areas.
